- Q. How did you go from being a minstrel and heavy metal performer to being a member of Chrome?
- A. I was looking around for a band to record with and I stumbled across it. I was playing with the bass player at Gulliver's Pub. He was playing violin and I was playing folk music. He was playing bass in Chrome (the first album). He said they were recording an album called The Visitation. He was pretty off into ... ah. He believed the Earth was the center of the Universe, this bass player. we used to have arguments about that. Or was it the Sun? He thought the Sun was the center of the Universe, one of the two. Anyway. I always told him he was wrong, but we always used to have a lot of fun arguments about stuff like that. And I go, I want to hear your record when its finished, though.


And I go, I want to hear your record when its finished, though. They were the only band in San Francisco making a record on an independent label, their own label. When I heard it I wanted to be in the band really bad. I liked the title "The Visitation" because I was into UFOs. I always try to follow leads on any information leading to serious discussion about UFOs, any answers, anything like that. actually, it was listening to Rainbow Bridge that got me to explore this certain crater in Eswaii. I actually went there just because of that record, just to hike through the crater. I've hiked through it three or four times since I discovered it.

- Q. Is there alien influence to the band. I always get that impression when I listen to it. It gives the feeling of rebel space guys.
- A. I don't know if that was purposely done. We sort of went off into that. That's sort of what attracted me to the band, as well as the effects and stuff. Those two where related; that alien music would be almost incomprehensible to humans. Then we went in to make an album (I don't know if you remamber it) called "No Humans Allowed", a totally non-musical album.
- Q. That also came out as "Read Only Memory"?
- A. Read Only Memory was part of No Humans Allowed.
- Q. Now ROM was supposed to be a soundtrack to a film.
- A. Yeah, I don't know if the film ever came out.
- Q. Who was making the film?
- A. Ian Turner. You know the Bauhouse/Chrome video that's for sale? He made the Chrome video.
- Q. Now you had Siren, the Chrome label.
- A. Yeah, that was Damon's label
- Q. Then you got on Beggars Banquet in England. How did that happen?
- A. We were already starting to sell a lot of records on our own label, right. We were trying to get on a major label, but we just kept getting turned down. Damon was in Europe and started talking to labels over there. Beggars banquet was interested in us, so we signed up to Beggars Banquet. We went on from there. They made a subsidiary label called "Don't Fall Off The Mountain". From that we went on to Faulty (Third From The Sun and the single "Firebomb"). Then we did Subterranean with "The Chrome Box" which was "Chronicles I & II" with all the older albums in a box. That was the last thing I did with Chrome.
- Q. On "Alien Soundtracks" you have a song about a drug (I forget the name of it) Was that based on anything?
- A. "ST-37". Yeah, its based on a product called ST-37. I don't know if you remember it; it was a green mouthwash back in the mid-'70s. We decided to pretend that it was a drug, sort of sister drug to LSD or something.
- Q. Would you recommend the use of any drug in particular?
- A. I think it should be up to the individual. If you are going to use drugs like speed, coke, acid and heroin you'd better be very careful (maybe not acid. well, all those kind of drugs). I think people should be educated on drugs and not be criminalized. I think they should be educated and if they have a need to do drugs, be allowed to do them. I think education on drugs would be more beneficial than criminalizing people, because if people know what they're getting into they're more likely to be more useful than abuseful, you know what I what I mean?

LETTER WRITER REVEALED



In the last issue of OTDE I reprinted a very strange letter that I had received. It seemed to be from someone claiming to be the Green River Killer. The most obvious explanation for this letter was that it was a hoax, as I stated when I printed the letter in OTDE 6/7. I printed the letter letting the reader decide what it meant. I thought that if it was a hoax, it was probably written by someone I knew. I had two major suspects in mind. Some time later, another friend told me that one of my suspects had told a girl that he had met at a bar that he had written a hoax letter to a small circulation magazine. If one were honest about investigating unexplained phenomena, presenting false information for whatever reason would not be the thing to do.*
